GENERAL INFORMATION

Mirage® Black Lake & Pond Colorant is a proprietary water soluble colorant designed for aesthetic applications in lakes, ponds, decorative water features and other impounded bodies of water. Mirage Black Lake & Pond Colorant beautifies murky, cloudy, or off-color water with a pleasing natural reflective tint.

DIRECTIONS FOR USE

- Remove bag from outer plastic bag with a dry, gloved hand. Toss the bags into the lake or pond, spacing evenly in the water area. The most effective applications will be where the bags are placed in deeper water, or next to aerators or turbulent areas.
- Bags will begin to dissolve in three to five minutes (somewhat longer in colder waters), releasing Mirage® Black Lake & Pond Colorant
- Dispersion of the color will depend on the movement of the water, but should occur within hours after treatment.
- Once color has been allowed to disperse completely, add bags, if needed, to maintain desired coloration.

FIRST AID INFORMATION

Avoid contact with eyes and skin - may cause temporary irritation. In case of contact, flush eyes / skin with large amounts of water. If irritation persists, seek prompt medical attention. Do not ingest. In case of ingestion, drink copious amounts of water and seek medical attention if irritation occurs.

KEEP OUT OF REACH OF CHILDREN

STORAGE AND DISPOSAL

Store in original and closed container in secured storage areas. Use caution when moving, opening and dispensing. Do not handle water soluble bags with wet hands, wet gloves, or place on wet surfaces. Keep from freezing as freezing may cause water soluble bags to become brittle. For all spills, sweep and dispose of free flowing powder. Disposal must comply with local, state, and federal regulations. Remaining spill should be attempted to be washed away with water. Use of soap and bleach can support the decolorization of the spill.

MIRAGE BLACK LAKE & POND COLORANT

- Natural reflective tint
- Enhance the appearance of murky, cloudy or off-colored water
- The diluted color in treated water will not harm fish, waterfowl, pets or wildlife.
- Water may be used for irrigation or fishing immediately following treatment.

PRECAUTIONARY STATEMENTS (READ CAREFULLY)

- Do not apply Mirage to water used for human consumption.
- Individual operators perceive color differently adjustments to the application rates may be necessary.
- Chlorinated water will cause color fading, requiring higher dosages or more frequent treatments.
- Please handle with care as colorant may stain skin and clothing
- Use caution before a general application of Mirage near porous surfaces (e.g. - concrete, rocks, stonework, brick, etc.)
- Decolorization may be obtained by applying a bleach, soap and water solution (1 part bleach, 1 part soap and 8 parts water)

RECOMMENDED APPLICATION RATES

Determine the number of acre feet in the lake or pond. Surface area in acres [length (ft) X width (ft) / 43,560] times the average depth (ft) = Acre Feet. An acre foot is the area covering one surface acre, 12 inches deep.

APPLICATION RATE	TREATED VOLUME
1 bag	1 acre foot (see above); 1,234 cubic meters
